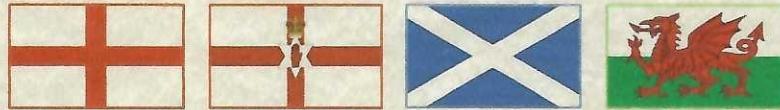

COURT ORDER

CONFIRMING THE VERDICT OF THE COURT

In relation to the Statement of Claim presented this day by John Smith (Plaintiff), the supporting evidence and the failure of the Defendants to appear, we the jury find the Defendants guilty on the following counts:

1. Their Fraudulent use of the statutory system and courts to target the Plaintiff.
2. The attempted theft of the Plaintiffs property.
3. Contempt of the Common Law Court.
4. The failure to recognise the authority of the people.

5. The failure to recognise the authority of the Common Law Court.
6. The failure of to accept lawfully issued Common Law Court deeds.

It is hereby ordered that after a unanimous decision of the court, the previous decision issued against the Plaintiff (Case. Ref. ABN – B365/13 Aberdeen Sheriff Court 06.10.17) by the statutory court, has now been annulled.

It is further ordered that the Defendants are liable for the following amount, £20,000 (each Defendant being liable for £6,666.66) to cover the loss of the Plaintiffs personal property and contents. This sum has been determined by the court and must be paid to the Plaintiff within a period of fourteen (14) days from the signed receipt of this order.

It is further ordered that the Defendants are liable for the following amount, £260,000 to compensate the Plaintiff for harm, injury and stress (each Defendant being liable for £86,666.66). This sum has been determined by the court and must be paid to the Plaintiff within a period of fourteen (14) days from the signed receipt of this order.

In the event that these orders are not complied with, the Common Law Court will take further action against the Defendants to enforce its decisions.

These Court Orders are effective as of this date and will remain in force until such time as they have been enforced. These orders are issued under the authority of this Common Law Court and jus gentium, the Law of Nations.
