6. The failure to accept lawfully issued Common Law Court deeds.

**It is hereby ordered** that the state and appropriate authorities may no longer unlawfully remove a child from it's parents if it has been established that the individuals concerned have confirmed their standing under common law and the jurisdiction of the Common Law Court.

**It is further ordered** that anyone involved in the unlawful removal of a child, through criminal coercion and the use of the legal fiction will be guilty of committing a crime against the people under common law and will be held liable in their personal and private capacity for damages.

In the event that these orders are not complied with, the Common Law Court will take further action against any individuals concerned, to enforce its decisions.

These Court Orders are effective as of this date and will remain in force to protect the people and their children. These orders are issued under the authority of this Common Law Court and jus gentium, the Law of Nations.
