Tribunal Clerk,

I write to inform you that in relation to the decision and the expenses awarded in relation to this case, this matter is still being disputed.

I have just submitted a revised Lawful Challenge to the Employment Appeal Tribunal, the Lord Advocate and the civil offices at the Court of Session and I am awaiting a date for a hearing or a suitable response.

I also wish to inform you that given the position of the Court of Session in relation to this matter I am now in the process of escalating it to the UK Supreme Court.

In the meantime, due to the fact that there is no time bar due the issue of fraud, I hereby require you to settle this counterclaim that I lodge here.

The counterclaim is for the payment required to comply with the Common Law Court Order (attached), and for the totals detailed within the order, see below:

15) A Kemp (acting as an Employment Judge, Employment Tribunal, Dundee, Scotland) has been found guilty of committing the above crimes, numbered 1 to 21 above, against the people and has unlawfully targeted John Smith.

A Kemp is now required to pay the living woman Kendra Mann, the sum of £25,000 for the unlawful prosecution raised against her.

A Kemp is also required to pay the sum of £5,000 for failing to dismiss the case when presented with paperwork from John Smith, for failing to allow a challenge to the tribunal's authority and jurisdiction and for also failing to deal with the issue of a conflict of laws.

16) Jay Lawson (acting as a solicitor, MML Law, Dundee, Scotland) has been found guilty of committing the above crimes, numbered 1 to 21 above, against the people and has unlawfully targeted a living woman, Kendra Mann and a living man, John Smith.

Jay Lawson is required to pay the sum of £5,000 to the living woman Kendra Mann for the unlawful prosecution raised against her.

Total due for counterclaim: £25,000 + £5,000 + £5,000 = £35,000

All sums which are due above are to be settled within fourteen (14) days from the date of this counterclaim. In the event that this matter is disputed, your response to this counterclaim is required within this same period.
